

Sandstorm Gold Releases Voting Results from Annual and Special Meeting

Vancouver, British Columbia | May 16, 2014

The Annual and Special Meeting of Shareholders of Sandstorm Gold Ltd. (the "Meeting") was held today, May 16 in Vancouver, British Columbia at which 66.3% of the issued shares (as of the record date for the Meeting) were represented. Shareholders voted in favour of all resolutions presented, including the re-election of all director nominees, namely Nolan Watson, David Awram, David E. De Witt, Andrew T. Swarthout and John P.A.
